

Doosan Forklift Parts

Doosan Infracore Company Ltd. is an international and intercontinental organization that includes Defense Industry Products, Industrial Vehicles, Diesel Engines, Automation Systems, Machine Tools and Construction Equipment. In the United States, Doosan Infracore America Corporation is headquartered in Suwanee, Georgia. It is home to a 170,000 square foot production facility, which is the home of the Compact Equipment and Construction department. West Caldwell, New Jersey is home to the Machine Tool division and Cleveland, Ohio is home to the Lift truck division. The U.S. headquarters in Georgia facilitates a first rate parts operation capable of supplying an excess of 25,000 line items to support Lift Truck, Compact Equipment, Machine Tool and Construction client wishes. There are well over 220 Doosan service and sales locations operating in Canada and the United States. Moreover, there are more than 90 independent dealers moving lift truck equipment and materials handling equipment. This network permits Doosan Infracore America to aggressively compete in this competitive market. The forklift product line remarkably comprises of 63 different products consisting of 82 various battery and engine configurations of Electric-powered and Internal Combustion vehicles. Capacities of these numerous vehicle models range from 3,000 to 33,000 lbs. All trucks are designed in an ISO 9001 qualified facility. Doosan Infracore America is the fastest growing lift truck company in the North American market, thanks to their reliability in retaining a high degree of consumer service quality and optimum product performance to all Doosan Infracore Forklift users. The U.S. lift Truck division located in Cleveland has a professional team experienced in Sales, Purchasing, Advertising, Logistical and Technical Support. At first the home-based forklift market in Korea was an open import enterprise. Korea Machinery Co. Ltd. began in 1960, to import fully assembled forklifts as part of a home-based machinery expansion venture. Product sales of these goods were originally targeted to state-run firms, large scale corporations, and the military. This eventually led to a unification with Daewoo Heavy Industries Ltd. In 1976, the Forklift Division commenced trade operations throughout Korea to overhaul and sell this heavy equipment. By 1978, a lift truck manufacturing plant was successfully completed. Continuous technical training grew to become the new focus for enhancing quality and product development. Daewoo started the first domestic lift truck business in 1967, and quickly gained a whopping 90% share in the Korean Materials Handling market. By the 1980's, Daewoo's sophisticated technological enhancements combined with sales success placed them in a position of significant expansion of their forklift operations. Caterpillar Industrial Inc. of the U.S. in 1981, proposed a cooperative venture project to assist them in the highly competitive North American materials handling market. This project proved highly profitable for Daewoo and their lift truck sales expanded greatly. In 1984, the company finished development of a new facility to help in producing high end value-added products for export. In 1993, the company had a global sales system and started exporting designs they had established through in-house expertise, as an sovereign brand. Certifications were then acquired from CE of Europe, UL of the United States and ISO 14001 and ISO 9001, securing expansion opportunities into overseas marketplaces.
